Thank you for choosing Jayroe Lordo and Catalano PA to assist with the 2020 taxes for Meals on Wheels of Horry County Inc. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

We will prepare the 2020 federal and state income tax returns for Meals on Wheels of Horry County Inc. Our engagement to prepare the 2020 tax returns will conclude with the delivery of the completed returns to management, or with e-filed returns, with the tax matters representative's signature and our subsequent submittal of the tax return.

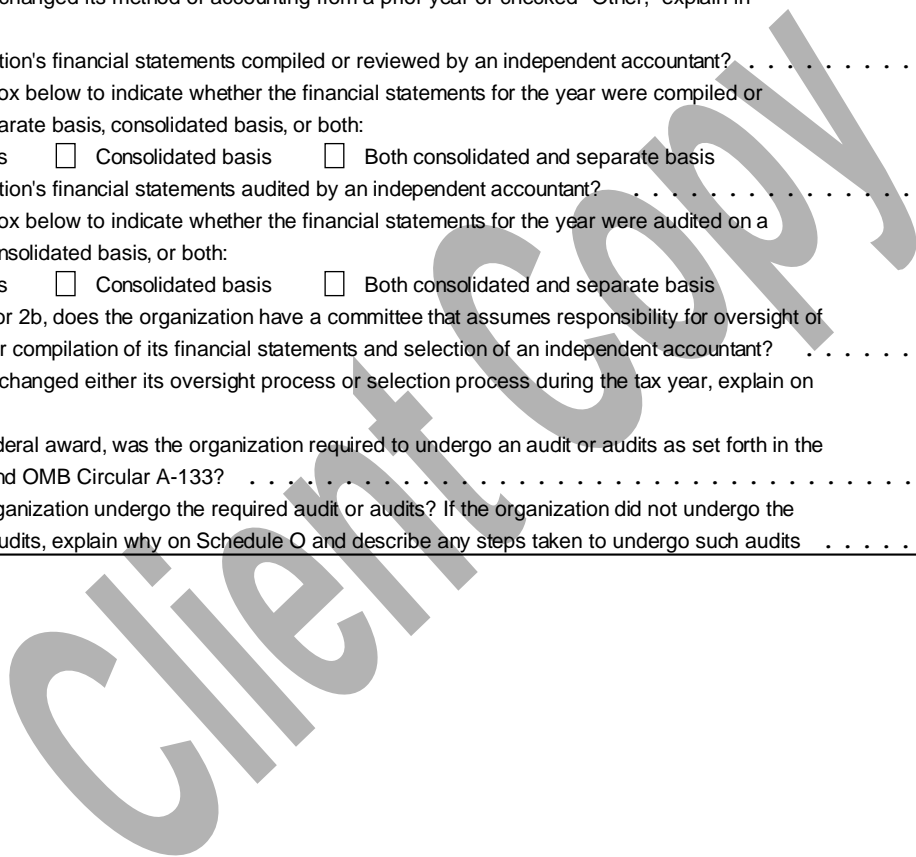
